Feed growing lambs 2 to 2 1/2% body weight to provide between 15 to 70 mg of Lasalocid per head per day along with alfalfa hay. Provide a source of fresh, clean water at all times. Do Not Feed wet, moldy or insect infested feed.

WARNING: A withdrawal period has not been established for this product in pre-ruminating cattle. Do not use in calves to be processed for veal.

CAUTION: The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equine access to feeds containing Lasalocid as ingestion may be fatal. Feed as directed.
